___ **Enrollment:** By signing the following page, you are agreeing to enroll your child for the entire school year, August until June. At registration, the first installment will cover tuition for the first and **last (June)** payment periods of the year will be charged at the beginning of the school year. These payments will not be refunded or transferred to other months' tuition regardless of future absence/leave or any other circumstances.

___ **Tuition:** ICEC basic tuition for the school year is divided into ten payment periods. The ten payment period plan is based on the ten months of the school year and accounts for any fluctuations or breaks during the school year (Spring Break, Winter Break, long weekends, holidays, etc.). The payment plan is a flat rate (see payment rates chart) that is based on the number of SCHOOL days. Parents may choose a different rate each period based on how many days per week their child(s) will attend in the period. Parents are obligated to submit full payment for each payment period. ICEC will not refund or deduct any amount of the payment based on absence/vacation.

___ **Payments:** Payments shall be submitted within 5 business days of the beginning of each payment period. Late payments will incur an additional 6% fee. For payments, ICEC accepts cash or check only.

___ **Enrichment Courses:** Enrichment courses and additional activities are charged on a monthly basis. There are no refunds or deductions in tuition for absence/vacation. There is an option for child(s) to attend make-up classes for only certain courses (see chart).

___ **Yearly Review:** A yearly review and signature acknowledgement of ICEC After School's policies are required.

___ **Cancellation Policy/Fee:** Should you decide to withdraw your child from the ICEC After School Program before June, you must give 30 days' notice to the Principal. The tuition paid for the last month at registration is not refundable or transferable under any circumstances. If you withdraw your child without giving 30 days' notice, the remaining month's tuition as well as the following month's tuition is to be paid.

Legal Information

As the parent or legal guardian of _____, I understand that there is a \$200 non-refundable registration fee for all new students for the International Cultural Exchange Center (ICEC) After School Program. I am agreeing to enroll my child for the entire school year, August until June. I agree to pay the registration fee and the tuition for the first month, as well as tuition for the last month as collateral—which will be applied to the last month's tuition. Should I decide to withdraw my child from the ICEC After School Program, I must give 30 days' notice to the principal. In terms of tuition and registration fee, I understand that the tuition of the last month of the entire school year and the registration fee are not refundable under any circumstances, nor is the tuition paid for the last month transferrable to other months' tuition.

I understand that not all students can be put into one program or class, and that spaces are not necessarily guaranteed in these programs or classes held by the ICEC After School Program. In terms of enrichment classes, I understand that I will pay for the Enrichment Class fees every month, not by every class, and these Enrichment Class fees are not refundable under any circumstances. If my child(s) miss any Enrichment Classes, I will contact the teacher to make up the lessons.

As the parent or legal guardian of the student named above, I hereby authorize this student to participate in the International Cultural Exchange Center After School Program. I understand the unlikely risk of an accident occurring. I also do hereby agree not to hold International Cultural Exchange Center Inc., its partners, staff, teachers, volunteers, aides, employees, or any other associate connected with International Cultural Exchange Center Inc. responsible for any damages or injuries occurring to persons or property, including injury and death. Liability and pick-up Waiver

This waiver form is to give a staff member of The ICEC After School Program permission to pick up your child at their school and to transport your child to the school. To facilitate this process, you need to give your school information to allow pickup by The ICEC After School Program staff and let the school know about our designated place for pickup.

In order to transport your child from school to The ICEC After School Program, several means of transportation will be utilized (depending upon the school's proximity to ICEC After School Program). ICEC After School Program staff will make every effort to ensure the safest and most direct possible route between the school and the ICEC facility and will make every reasonable effort to ensure the safety of your child during transport.

I, _____, hereby release The ICEC After School Program, LLC, from any and all liability regarding any transportation to The ICEC After School Program and any subsequent activity at ICEC After School Program. Signing this form is a precondition to participating in after school club events and activities.

1. I understand that The ICEC After School Program is constituted as a group of individuals who have organized for the purpose of enjoying each other's company while playing at the park, in our facility, board and card games (game activities), and that these activities are considered a voluntary assembly for mutual enjoyment in a social situation. Furthermore, The ICEC After School Program is a parent organization only in the sense that it may facilitate such assemblies. Each individual is acting as a voluntary member and as such is responsible for his or her own actions.

2. I acknowledge that my child's participation in game activities does pose an unlikely, limited risk of injury to the child and his/her personal property. Furthermore, my child's participation in any activity is voluntary. I am assuming responsibility and liability for my child's behavior and actions.

3. I acknowledge that transportation between my child's school and the ICEC After School Program is associated with risks that are consistent with walking from the school grounds to ICEC's vehicle and being transported to any parks and recreational centers. If my child's behavior during transportation poses a potential threat to the safety of other children/staff during transport, I understand that this may result in a termination of after school pick up services from the ICEC After School Program.

4. I understand that I am responsible for my child's behavior that results in damage to any "games for play" provided by ICEC After School Program and will be held responsible for costs associated with replacing parts, cards, pieces or the game in its entirety if the game is deemed "unusable" as a result of the aforementioned behavior.

5. I hereby solely and expressly assume liability for all risks and waive any claim I might have against The ICEC After School Program or anybody or individuals acting in the capacity as agents of the organization (staff members, etc.). I assume full legal liability for my child's actions at game activities and release The ICEC After School Program and any agent acting on behalf of The ICEC After School Program, LLC from any claims made as a result of my actions.
